1. Possibility of partial withdrawal of funds from the deposit before the expiration of the deposit	not allowed

Procedure for early termination of the deposit agreement	If the deposit is claimed early, interest is paid for the full number of days the funds are on the deposit in the following amount: no interest is paid for up to 3 months, from 3 to 6 months - at a rate of 8% per annum, from 6 to 12 months - at a rate of 10% per annum, from 12 to 18 months - at a rate of 12% per annum, over 18 months - 13% per annum. The amount of interest paid in excess due to early withdrawal of the deposit is withheld from the deposit amount
