

CONSENT TO PERSONAL DATA PROCESSING

By expressing this Consent, I act freely, in my own interests, and of my own will, hereby granting ASIA ALLIANCE BANK JSC (hereinafter referred to as the "Bank") and third parties who have and/or may have a relationship to the conclusion and/or execution and/or servicing of any transactions/operations concluded (or which may be concluded) between myself (or a person representing my interests) and the Bank,

my unconditional, informed and conscious consent and right to collect, record, process, systematize, accumulate, store, modify, supplement, clarify (update or change), extract, use, transfer (provide, access), depersonalize, block, delete, destroy my personal and financial data recorded on electronic, paper, or other material media, including photographic images and video recordings, as well as data obtained from state databases, and other personal data at the disposal of third parties acting on behalf of the Bank,

by carrying out the actions stipulated by the Law of the Republic of Uzbekistan "On Personal Data," using automation tools or without them,

for the purpose of the Bank considering the possibility of concluding contracts/offers with me for the provision of all types of banking services offered by the Bank, informing me about the results of the consideration of applications submitted by me for the provision of certain banking services, about other products and services of the Bank and its partners by sending relevant information using any means of communication according to the contact details I provided to the Bank, as well as to update the Bank's information databases.

I also consent to:

- obtaining personal information about me from the NIDBD/ICPA/STC system and mobile phone operators;

- provision/receipt by the Bank of all available information and data on credit products about me in the volume, manner and under the conditions necessary for my identification, conducting an appropriate assessment of my creditworthiness in state and non-state departments and organizations, obtaining a credit report from them, making/changing/removing entries in the SUE "Pledge Registry";

- obtaining information about property: information about my property and/or the property of third parties that serves as security for obligations, information on the presence/absence of encumbrances (arrests) on the property; identification data, information on the presence (absence) of registration, encumbrances; general characteristics of the property; value; address (location) of the property, state registration data and other information;

- obtaining information necessary to assess my ability to pay: pension contributions, information on official and other income and expenses, etc.; information on the availability/absence of loans (borrowings), bank accounts, funds and securities, including those under trust management and safekeeping, information on the amount of taxes paid and tax arrears;

- obtaining information about family/social status;

- obtaining information necessary for the provision of high-quality services and their improvement, personalization of the provided services, including remote services;

- use of the following methods of interaction: telephone conversations, postal items, SMS notifications, text, voice and other messages transmitted through communication networks and using the Internet;

- written appeals and sending of inquiries by the Bank to the place of registration, the address of actual residence and the address of place of work, which I provided;

- obtaining other information necessary for the Bank, including for filling out questionnaires, forming dossiers (client files), in accordance with the requirements of the legislation of the Republic of Uzbekistan and the Bank's internal documents (including information about my participation in the capital of legal entities - participation share, number (share) of shares, positions held, as well as information on changes and/or additions to such data, list of legal entities I represent) for the Bank's interaction with database operators, Bank counterparties, and third

parties.

I hereby express my consent and authorize the Bank to provide, in whole or in part, the information (personal data) listed in the above-mentioned paragraphs of this Consent, to third parties with whom the Bank has concluded an agreement on confidentiality and non-disclosure of information, for the purpose of processing, including such processing by a third party.

I confirm that all data I provide to the Bank is complete and accurate.

By giving this consent, I undertake not to post knowingly false information when registering in the Bank's mobile application using someone else's personal data (personal data of third parties, as well as fictitious persons).

I am also informed and agree that the Bank is not responsible for any potential misuse of users' personal information that may occur due to technical malfunctions in software, servers, or computer networks beyond the Bank's control.

I understand and agree that to terminate the Bank's use of my personal data, except for the storage of personal data as stipulated by the legislation of the Republic of Uzbekistan, I must contact the Bank to formally withdraw this consent in writing.

This consent may be provided to third parties as evidence that I have indeed given consent for the collection and processing of my personal data.

In connection with granting this consent, I request the Bank, as well as its partners/counterparties, to implement legal, organizational, and technical measures to protect my personal data, ensuring:

- the realization of my rights to protection from interference in my private life;
- the integrity and security of personal and financial data;
- the maintenance of personal data confidentiality;
- the prevention of illegal processing of personal data.

I have granted this consent for an indefinite period, and it remains valid until I withdraw it.
